The Occupational Health and Safety Administration's Safe + Sound Campaign encourages every workplace in the U.S. to have a safety and health program, a proactive approach to identifying and managing workplace hazards, before they cause injury or illness.

ICPA's **SAFE PLANT** is based on OSHA Safe + Sound Campaign and includes management leadership, worker participation, and a systematic process for finding and fixing hazards. As a partner in the Safe + Sound Campaign, the ICPA **SAFE PLANT** program will provide to its participating members a comprehensive program with access to tools and resources, including live webinars, to help develop or improve safety and health programs in the plant.

CORE ELEMENTS OF SAFETY AND HEALTH PROGRAMS

2. Worker Participation



3. Finding & Fixing Hazards



ICPA members participating in the **SAFE PLANT** program agree to make continual, year to year progress by implementing in their plant OSHA's recommended practices for safety and health. Participation in the **SAFE PLANT** program can reduce costs, including significant reductions in worker's compensation premiums, prevent workplace injuries, engage workers, increase productivity, and help with regulatory compliance. Member companies participating in the program will receive the framework for plant self-assessment, company safety and health improvement planning tool and resources, as well as receiving a certificate of participation and recognition from the association at POLYCON.

HOW TO PARTICIPATE

ICPA member companies that agree to participate in the **SAFE PLANT** program, will use the **SAFE PLANT** self-assessment tool, available at the ICPA website members portal. This form must be used to evaluate existing implementation of the OSHA recommended practices and identify areas for improvement for the year. Once that form is completed, the company can use the online form certifying their participation. Participating members will be recognized at POLYCON 2019!

Get Started in the SAFE PLANT Program

Don't wait – start today!

1. Review the **SAFE PLANT** program materials on the ICPA website
2. Commit to starting or improving a plant safety and health program
3. Engage employees in the program
4. Complete the **SAFE PLANT** self-assessment tool
5. Seek worker input on workplace changes
6. Enroll in the **SAFE PLANT** program and let the ICPA know of your participation by filling out the online form
7. Address any plant emergencies right away
8. Improve or start a **PLANT SAFE** program in your facility
9. Implement the plan with staff input, use a reporting system, provide training, conduct safety inspections, etc.
10. Collect hazard control ideas and Implement hazard controls
11. Display the **SAFE PLANT** logo and certificate in your facility as a reminder of the commitment to safety and health!
